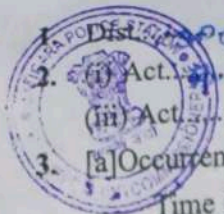

Sir,

In producing herewith One arrested accused person named Rajender Chouhan (34) s/o Late Kishan Chouhan of Baniakhari, Tripalijote, PS- Matigara, Dist.-Darjeeling along with following articles under proper seizure list.

1. 15(Fifteen) Bottles of "HIMALAYAN GOLD 60 UP COUNTRY SPIRIT" each Bottle containing 650 ml. [Total 9.75 Ltrs] and marked as Exhibit "A" out of which One (01) Bottle of "HIMALAYAN GOLD 60 UP COUNTRY SPIRIT" containing 650 ml. taken as sample for examination and marked as Exhibit "A-1".


I, SI Sailesh Subba of Matigara P.S, SPC would like to lodge this written complaint against the above noted accused namely Rajender Chouhan, PS- Matigara, Dist.-Darjeeling to the effect that today on 24.03.2023 at about 17.15 Hrs. I, received a specific source information that one Rajender Chouhan of Baniakhari is selling illicit liquor at his house. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 1543, Dated 23.03.23 and informed the fact to the officer-In-Charge, Matigara PS and as per his kind order and direction myself along with ASI Tapan Das, C/1053 Paresh Rava, and C/974 Pintu Sen all of Matigara PS left for Baniakhari under PS- Matigara to work out the information in hand. After arrival at Baniakhari I, being identified by the source we held raid at the house of said Rajender Chouhan and managed to apprehend one person. On being asked he disclosed his identity as noted above and also disclosed that he has been selling illicit liquor at his house without any license for his wrongful gain. Further in presence of witnesses and in presence of the apprehended person I, along with my accompanied team searched the above noted place and recovered above noted huge amount of illicit liquor from his house. On demand he failed to produce any valid license/papers for selling and storing illicit liquor. On further interrogation he stated that he has been involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above-mentioned liquor under proper seizure list and arrested the above noted person named Rajender Chouhan (34) s/o Kishan Chouhan of Baniakhari, Tripalijote, PS- Matigara, Dist.-Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 24.03.23 in between 17.55 Hrs to 18.25 Hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against arrested accused namely Rajender Chouhan (34) s/o Kishan Chouhan of Baniakhari, Tripalijote, PS- Matigara, Dist.-Darjeeling and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
