Sir,

In producing here with one arrested accused namely Utpal Barman (20), S/O Bijay Kumar Barman of Dumriguri Chhat, Tarabari School ground, PS - Matigara, Dist - Darjeeling along with seized article, I AS.I. Lxman Saha of Matigara P.S do hereby lodge a written complaint against the above noted arrested accused person to the effect that on 25.03.2023 at around 07.15 hrs in course of mobile van duty I received a information from reliable source that one Tractor loaded with illegally mining river bed materials coming from Tarabari side. On receiving the information I along with available force rushed to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at Lalinpur, Shiv Mandir under Matigara P.S area, I found the said Tractor bearing Reg No. WB G 5143 loaded with river bed material going towards Shiv Mandir Subsequently, I manage to stop the vehicle and asked the driver to produce valid documents / papers of the said river bed materials, but he did not produce any valid documents in support of said materials. As such I also seized the above noted loaded tractor under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses and arrested the driver namely Utpal Barman (20), S/O Bijay Kumar Barman of Dumriguri Chhat, Tarabari School ground, PS - Matigara, Dist - Darjeeling under proper memo of arrest and brought to the P.S.

Therefore I pray before you a specific case may kindly be started against the driver of the vehicle namely Utpal barman (20), S/O Bijay Kumar Barman of Dumriguri Chhat, Tarabari School ground, PS - Matigara, Dist - Darjeeling.
