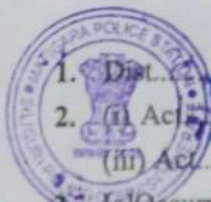

Sir,

In producing herewith one arrested accused namely Ujal Paul (25 yrs), S/O Uttam Pul of Goyal Jote, PO- Nema, PS - Matigara, Dist - Darjeeling along with seized articles I AS.I. Dharendra Nah Mandal of Matigara P.S, SPC do hereby lodge a Complaint against the above noted accused person to the effect that on 25.03.2023 at 08:00 hrs I received an information from reliable source that one Tractor loaded with illegally mining riverbed materials coming from Bansbari Ghat side. On receiving the information I along with available force rushed to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at Bansbari Ghat under Matigara P.S area, I found said Tractor bearing Reg No. WB 73 G 3710 loaded with river bed materials going towards Khaprai Road. Subsequently, I manage to stop the vehicle and asked the driver to produce valid documents / papers of the said river bed materials, but he did not produce any valid documents in support of said materials. As such I also seized the above noted loaded tractor under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses and arrested the driver namely Ujal Paul (25 yrs), S/O Uttam Pul of Goyal Jote, PO- Nema, PS - Matigara, Dist - Darjeeling under proper memo of arrest and brought to the above noted vehicle at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle namely Ujal Paul (25 yrs), S/O Uttam Pul of Goyal Jote, PO- Nema, PS - Matigara, Dist - Darjeeling and the seized vehicle bearing Reg No. WB 73 G 3710 under proper section of law and arrange for its investigation.
