Sir,

In producing herewith the 02 (two) arrested accused persons namely 1. Bishal Mukhia (33) S/O Lt. Lal Bahadur Mukhia of Salugara, P.S- Bhaktinagar, Dist.- Jalpaiguri, (Not verified) and 2. Miki Paswan (30) S/O Lt. Ashrafi Paswan of Salugara, P.S- Bhaktinagar, Dist.- Jalpaiguri (Not verified) along with the following seized articles under proper seizure list :-

- (i) One blue colour Celeriox Vehicle having Reg. No. WB 74 BE 5113.
- (ii) One Transparent plastic Pouch containing total 282 (two hundred and eighty-two) Gram of suspect of be Brown Sugar - seized from the exclusive possession of Bishal Mukhia (33) S/O Lt. Lal Bahadur Mukhia of Salugara, P.S- Bhaktinagar, Dist.- Jalpaiguri and marked as Marked as Exhibit-"A".
- (iii) One Transparent plastic Pouch containing total 308 (three hundred and eight) Gram of suspect of be Brown Sugar - seized from the exclusive possession of Miki Paswan (30) S/O Lt. Ashrafi Paswan of Salugara, P.S- Bhaktinagar, Dist.- Jalpaiguri and marked as Marked as Exhibit-"B".
- (iv) One black & Brown colour bag styled as "@ Sports".
- (v) One black colour plastic bag & green colour bag.

I, SI Newton Biswas of New Jalpaiguri Police station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted 02 (two) arrested accused persons to the effect that today 22.03.2023 at about 12.05 hrs I received a specific source input that two persons were standing at in front of Sat Sangha Ashram, Thakurnagar area under NJP P.S , SPC with a blue colour vehicle with huge quantity of Brown Sugar for delivering the same to his designed customers. The matter was diarized vide NJP PS PS GDE No. **1003** Dt. 22.03.2023 and I informed the matter to SI Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri Police Station, Siliguri Police Commissionerate in writing a letter to him and expressed the entire information. As per his kind direction myself along with other officers and force named ASI Sajal Das, CV/824 Niru Kumar Yadav, CV/306 Biswajit Roy, VP/08 Laxman Roy all of NJP PS, Siliguri Police Commissionerate being headed by me left for in front of Sat Sangha Ashram, P.S- NJP, Dist.- Jalpaiguri by govt. vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No **1004** dated 22.03.2023 and M.C.C. No. 511/23 dated 22.03.2023.. In the mean time I also informed the RT Van Officer SI Pintu Ghosh & LSI Sahana Parveen of New Jalpaiguri PS, Siliguri Police Commissionerate, to accompany us. Further I also informed the Videographer namely Tapan Mandal s/o Testo Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present at in front of Sat Sangha Ashram, Thakurnagar area, P.S- New Jalpaiguri, Dist.- Jalpaiguri to prepare the Video of whole process of search and seizure if any. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 12.35 hrs we arrived at in front of Sat Sangha Ashram, Thakurnagar, PS- New Jalpaiguri, Dist.- Jalpaiguri and on the way to the spot, I called two independent witnesses namely (i) Amit Roy (27) S/O S/O bablu Roy of Baribhasa, Madani Bazar, PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) Kartick Das (22) S/O Gopal Das of Baribhasa, P.S- NJP, Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as witnesses under relevant provision of law. After arrival at the spot and as identified by the source we found that one blue colour Celeriox vehicle having Reg. No. WB 74 BE 5113 was standing in front of Sat Sangha Ashram, Thakurnagar, PS-New Jalpaiguri, Dist.- Jalpaiguri which was matched with our information. Accordingly, we intercepted that vehicle and found that one Bishal Mukhia was found in driver seat and one Miki Paswan found beside the driver seat who disclosed their identity as noted above.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely 1. Bishal Mukhia (33) S/O Lt. Lal Bahadur Mukhia of Salugara, P.S- Bhaktinagar, Dist.- Jalpaiguri, (Not verified) and 2. Miki Paswan (30) S/O Lt. Ashrafi Paswan of Salugara, P.S- Bhaktinagar, Dist.- Jalpaiguri (Not verified) are involved in procuring and selling of Brown Sugar illegally and contravening the norms of NDPS Act was established, Then, I arrested the above noted accused persons after observing all guidelines of Apex court of arrest as well as after disclosing the cause of arrest and issued necessary Memo of Arrest. The whole process of Search, seizure & Label was made in-between 13.15 hrs to 14.30 hrs on 22.03.2023.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the above noted arrested accused persons namely 1. Bishal Mukhia (33) S/O Lt. Lal Bahadur Mukhia of Salugara, P.S- Bhaktinagar, Dist.- Jalpaiguri, (Not verified) and 2. Miki Paswan (30) S/O Lt. Ashrafi Paswan of Salugara, P.S- Bhaktinagar, Dist.- Jalpaiguri (Not verified) 3. Md. Samim Akhtar S/O Md. Dukhu Momin, Vill + P.O- Jadupur, P.S- Kaliyachak, Dist.- Malda (Not verified) 4. Raju Saha S/O Balaram Saha of Karala Whita, P.S- Gazole, Dist.- Malda (Not verified) & others and arrange for its investigation.
