I beg to inform you that today i.e 24.0323 at 20.10 hrs received information that two persons were moving suspiciously at Payel more near Traffic point under Bhaktinagar PS. Diarized the matter in GD vide Bhaktinagar PS GDE no-1376 dated 24.03.23 and as per your kind direction myself along with PSI Koushik Raha, Const/374 Debraj Biswas, C/1431 Dilip Barman, CV/014 Labonnomoy Barman and CVF/619 Dharmendra Roy left for Payel more near Traffic point to verify the information. Immediately we reached at Payel more near Traffic point at 20.25 hours, that time we noticed that the above noted accused persons loitering suspiciously near Traffic point at Payel more. We detained them and on being asked they disclosed their name and address as noted above. On demand the persons failed to produce any valid Visas or documents to entry into India from Bangladesh.
