Respected Sir,

I, **MOUSUMI GHOSH**, W/O Biswajit Ghosh, Resident of Biswajit Ghosh, Ranidanga, P.O. & P.S. Bagdogra, Dist. Darjeeling, West Bengal, do hereby want to inform you as follows :-

1. That I am the law abiding citizen of India.
2. That I had lodged this FIR against **SURESH RABIDAS**, S/O Shubelal Rabidas, Resident of Dhamigach, sonapurhat, Chopra, Diat. Uttar Dinajpur, for misappropriating of the vehicle being No. WB- 74BG- 2914, Chasis No. MA3JMT31SMF499493, Engine No. K10BN85339173, Model 2021.
3. That I am the registered owner of vehicle being No. WB- 74BG- 2914, Chasis No. MA3JMT31SMF499493, Engine No. K10BN85339173, Model 2021 which is hypothecated to Axis Bank Ltd. Siliguri Branch.
4. That I being a lady, I was unable to run the said vehicle being No. WB- 74BG- 2914 and due to which I offered the said **SURESH RABIDAS**, S/O Shubelal Rabidas for running my said vehicle being No. WB- 74BG- 2914 and being so offered and trusting upon the said **SURESH RABIDAS**, S/O Shubelal Rabidas I handed over the said vehicle to the said **SURESH RABIDAS**, S/O Shubelal Rabidas and the said **SURESH RABIDAS**, S/O Shubelal Rabidas executed one Notarial Power of attorney for plying the said vehicle on road.
5. That at the time of handover the said vehicle to the said **SURESH RABIDAS**, S/O Shubelal Rabidas, assured me that he will pay the monthly installment a sum of **Rs. 13,316/- (Rupees Thirteen Thousand Three Hundred Sixteen only)** to Axis Bank Ltd. Siliguri Branch as the said vehicle was hypothecated under the said concern.



6. That the said **SURESH RABIDAS**, S/O Shubelal Rabidas, also assured me that he shall not engage my said vehicle in any illegal purpose.
7. That I upon his assurance and keeping in mind of the good relation with him, I hand over the said vehicle being No. WB- 74BG- 2914 to in favour of the said **SURESH RABIDAS**, S/O Shubelal Rabidas, subject to the condition that the said **SURESH RABIDAS**, S/O Shubelal Rabidas, will regularly pay the monthly hypothecation installment as mentioned earlier to the concern hypothecation company and also will also assured me that he will not alienate the said vehicle to any other party.
8. That subsequently on 09.03.2023, I received one legal notice from the concerned bank wherein I came to know that the said **SURESH RABIDAS**, S/O Shubelal Rabidas, by breaching my trust did not pay any installment amount to the concerned bank and when I asked to the said **SURESH RABIDAS**, S/O Shubelal Rabidas, about the non payment of the installment amounts, but being asked by me the said **SURESH RABIDAS**, S/O Shubelal Rabidas, become furious and stated to abuse me with filthy languages and threatened me that if I ever demand any money from him in future he will engage my aforesaid vehicle in illegal purposes and will implicated me in false cases.
9. That subsequently I came to know that my aforesaid vehicle was being sold by the said **SURESH RABIDAS**, S/O Shubelal Rabidas by way of breaching my trust and misappropriating my property, forging my signature on various documents.
10. That subsequently when, I requested the said **SURESH RABIDAS**, S/O Shubelal Rabidas, to return the said vehicle, but the said **SURESH RABIDAS**, S/O Shubelal Rabidas, became violent and started to treat me that if again came to him then he will kill me and my family members and also threat me that he will not return me any amount, by this way the accused person misappropriated my property by way of cheating.
11. That the said **SURESH RABIDAS**, S/O Shubelal Rabidas, also did not paid the hypothecation installments to the concern finance company and as a result a huge amount of installments become due and as a vehicle is registered in my name hence the hypothecation company stated legal process against me for which the said **SURESH RABIDAS**, S/O Shubelal Rabidas, is solely liable and responsible for the same.
12. That finding no other alternative I requested **SURESH RABIDAS**, S/O Shubelal Rabidas to return back my aforesaid vehicle but the said **SURESH RABIDAS**, S/O Shubelal Rabidas, with malafide intention to and misappropriate my vehicle refused to return back my aforesaid vehicle and threat me that he will never ever return my vehicle and also threatened me that if I do not pay him a sum of **Rs. 10,00,000/- (Rupees Ten Lakh only)** the he will implicate me in false cases with and intention to **extort** money from me.

13. That the above named person namely **SURESH RABIDAS**, S/O Shubelal Rabidas misappropriating my property and commits a criminal breach of trust with me and it is nothing but a process of cheating and misappropriating my property.

14. That the above named person's namely **SURESH RABIDAS**, S/O Shubelal Rabidas cheated, misappropriated willfully and fraudulent act/s clearly and manifestly proves the fact that the above named person had fraudulent & dishonest intention of cheating the huge money for his personal gain and has thereby misappropriated my property, which was their underlying intention and design.

15. That under such circumstances, I being a distress lady pray before you to take serious legal action against the said **SURESH RABIDAS**, S/O Shubelal Rabidas alleged person who has cheated me and misappropriated my property, and criminally breach my trust and put me in a condition where I have no financial capacity to secure my future life as well as to run our day to day livelihood and the above named person by taking advantage of my distresses, succeed to cheat me.

I therefore request before your good self to kindly look into the matter and take necessary strong action against the above named persons namely **SURESH RABIDAS**, S/O Shubelal Rabidas as per the provision of law and for this act of kindness I shall remain extremely great full to you.
