Sir,

With due respect, In producing herewith one accused person namely Md Saddam (30) S/O- MD. Pozir of Kaluajote ,P.S- Naxalbari , Dist- Darjeeling under arrest along with seized cattle and seized vehicle :-

- (i) Six (06) numbers of Cattle in different color and size.
- (ii) One White color TATA Yodha-1700 vehicle (Pick Up Van) having registration No- WB-73-G-0575 which was used to carry the seized cattle SL. No. 1.

I ,ASI Jakirul Islam Of Bagdogra PS under Siliguri Police Commissionerate do here by lodged a written complaint against the above noted accused person to the effect that on the night 23/24-03-2023 myself alongwith force C/851 Chandan Debnath VP-02 Pradip Roy, VP-01 Ansalam Kujur CV-386 Kishore Howladar and CV-375 Jogesh Barman were performed Spl. Night mobile van duty and during mobile duty at 02:05 hrs I received a secret source information that one Pickup Van having Registration No WB-73-G-0575 was coming on Ashian High way from Naxalbari side with loaded of huge cattle's illegally towards Bagdogra side . If the information would not be perused immediately those Cattles would have been concealed by them. Accordingly I shared the information to duty officer which is diarized vide Bagdogra P.S. G.D.E. No-1328 date 24/03/2023 and also shared the information with OC Bagdogra PS. Thereafter as per his direction myself alongwith force left for Kestopur More under Bagdogra PS to verify the veracity of information. At 02-25 hrs we reached at Kestopur More and on the basis of secret information we intercepted the vehicle i.e. one white color pick up and apprehended the driver of the said vehicle. On checking the vehicle we found 6 (five) numbers of cattle in different color and size were loaded on the vehicle. On being asked the apprehended driver disclosed their name and address mentioned above and stated that he was carrying these Cattle to Fulbari side, Jalpaiguri for sale from Naxalbari side . On asked, he failed to produce any valid License/ papers to carrying the said Cattle in that vehicle and also failed to produce any papers in respect of the said Cattles. On further checking it was found that there was no arrangement made for food and water for the Cattle as per govt. rules which he was carrying in that vehicle. Besides, this there was no sufficient space for the cattle in that vehicle and all of them were tied with ropes. The above noted driver of the said vehicle also failed to produce any papers/documents in support of the said vehicle. Accordingly I seized the 6 (six) numbers of cattles in different color and size and the Vehicle TATA Yodha-1700 vehicle (Pick Up Van) having registration No- WB-73-G-0575 under proper seizure list on search disinterest witnesses but could not found due to mid night and arrested the above noted accused person U/S 41 Cr P.C , informing him the grounds of his arrest as he is violation of The Prevention of Cruelty to Animals Act 1960. The seized cattles handed over to the Fulbari Khoyar for safe custody. The seizure and arrest have been made in between 02-35 hrs to 03-05 hrs.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused person namely Md Saddam (30) S/O- MD. Pozir of Kaluajote ,P.S- Naxalbari , Dist- Darjeeling to arranged for its investigation.
