In producing herewith 01(One) arrested persons namely (1) Pankaj Sahani S/O Lt- Prakash Sahani of Kuli Para, W/No-01, PS-Pradhannagar, Dist-Darjeeling A/P-Shantinagar,Bou Bazar,W/No-22,PS-Siliguri,Dist-Darjeeling..(Paddler 'of Toto (E-rickshaw), without number plate, blue colour). Along with his Toto under seizer, I SI. Arindam Chatterjee of Junction Traffic Guard, Siliguri Police Commissionerate do here by lodge written complaint against him to the effect that, on 25.03.2023 I along with ASI.(AB) 474 Santosh Mandal, CV-507 Sujan Shil, while performing traffic regulation duty at NH-10, near Darjeeling More found that, the above noted person was plying his Totos (E-rickshaw), as noted above on NH-10 by violating Govt. Order vide Notification number 1526/1(1)/-WT/3M-56/13/PT.II Dated-27.04.2015 of Principal Secretary to the Govt. of West Bengal and also disrupting the free flow of traffic by stopping here and there disorderly for collect passengers.
