Sir,

With due respect and humble submission, in producing herewith one accused namely Vaskar Rai (34 years) S/O Sri Maila rai of Amba T.G P.S- Kurseong, Dist.Darjeeling under arrest along with following articles under proper seizure ;

- i) **27 (Twenty-seven) bottles of KINGFISHER , Strong ,Premium BEER ,each bottle containing 650 ML, each MRP 125/- (Total 17.550 Ltrs)**

I SI Abhishek Theengh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person and others to the effect that today on 26.03.23 I was engaged in mobile van duty along with force CV/128 Ajay Kr Sahani ,CV/645 Pankaj Gupta L/C 720 Mithu Kabiraj all of Pradhannagar P.S, vide Pradhannagar PS GDE No. 1521 dtd.26.03.2023 during mobile van duty I received source information that at 15.25 hrs I received an information that owner and stuff of Nepali Kitchen ,Lama Hotel at Siliguri Junction area under Pradhannagar P.S storage huge quantity of illegal liquor and selling the same openly . Accordingly I informed to you and as per your direction myself along with force held raid in the said Hotel and on seeing police party the owner of the hotel fled way from her hotel and one person stuff of Nepali Kitchen ,Lama Hotel is selling the liquor to customer , then I detained the above noted person and on being search said hotel recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document with the help of owner of hotel namely Smt. Priyanbada Rai W/o Binod Rai of Murmha T.E P.S- Mirik,Dist.Darjeeling for their illegal gain. Accordingly, I seized & label the above noted articles in between 15.35 hrs to 16.05 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Vaskar Rai (34 years) S/O Sri Maila rai of Amba T.G P.S- Kurseong ,Dist.Darjeeling and Smt. Priyanbada Rai W/o Binod Rai of Murmha T.E P.S- Mirik,Dist.Darjeeling owner of the Nepali Kitchen ,Lama Hotel and arrange for its investigation.
