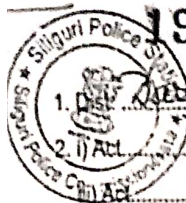

I had my Voter card (MHX3988821), Driving License (W.B.7320140247246), two ATM card of SBI & icici Bank in that Wallet.

He did this incident yesterday, When I sent him to Bank (SBI, Branch: ghoghomali) for Deposit money at time 11:45a.m. I told him to go Subhaspally where the garage (Ph-9832432104) is located for repair my Scotty Before going to bank. He called me when he reached the garage & it was the last contact between him & me.

When he didn't come for Long time from Bank to our Shop, I called him. But he didn't receive my Call. After trying many times I went to the Bank. But he was not there & then I go to his home. But the door was locked. I ask the neighbors about him, but no one could give proper information about him.

I trusted him, but he dishonestly cheated me by doing this type of activity. After some investigation I found that he also cheated with some others People.

Please take the necessary legal action against him.
