Subject- F.I.R. against my husband Sri Jiten Oraon, resident of Litchi Bagan, Matigara, P.S- Matigara, Dist- Darjeeling (contact no- 9679411113 / 8016050449) and Smt Priya Barik @ Smt Diksha Barik, resident of- Jayantika Tea Estate, Godown Line, Bidhannagar, Post office- Sahabad, Dist- Darjeeling. (Contact number - 7029845299)

I, Smt Tumpa Oraon, wife of Sri Jiten Oraon, resident of Litchi Bagan, Matigara, P.S- Matigara, Dist- Darjeeling intend to lodge this complaint against my husband Sri Jiten Oraon and Smt Priya Barik @ Smt Diksha Barik to the effect that my marriage was solemnized with Sri Jiten Oraon on 21st of December 2012 according to Hindu Rites and Customs and out of our wedlock two children was born namely Master Tanuj Oraon and Miss Jaina Oran on 2014 and 2018 respectively. My husband since my first pregnancy in the year 2014 started to apply tortures upon me mentally. During my pregnancy period my husband used to come home in late night and abused me with abusive slangs. Thereafter the quantum of physically assaults increased after the birth of my first child. My husband my husband used to increase the assault used to physically hit me without any reasons. Upon my protest husband used to physically hit me and out shed me from my matrimonial house. My husband kept torturing me mentally and physically hit me in an extreme state. That in the year 2018 during my second pregnancy I discovered that my husband is into an extra marital affair with one Smt Priya Barik @ Smt Diksha Barik, daughter of

Sri Dipak Barik. After the birth of my second child my husband continued his extra marital affair without any fear and kept to continue the same. Finding no

other alternative on several occasions I explained aforesaid Smt Priya Barik @ Smt Diksha Barik with the fact that my husband is a married man having two minor children and she should restrain herself from such relationship but the illicit affair between my husband and Smt Priya Barik @ Smt Diksha Barik is continuing till date. Said Smt Priya Barik @ Smt Diksha Barik abused me with vulgar languages on several occasions and provoked my husband against me resulting which my husband used to assault me by hitting me mercilessly. In the September 2020, my husband and Smt Priya Barik @ Smt Diksha Barik conspired and tried to kill me by mixing poison in my food resulting which I was in the edge of death. I was treated by ayurvedic medicines and was in recovery condition for about 2 to 3 months. I was threatened with death by my husband and Smt Priya Barik @ Smt Diksha Barik if any complaint was lodge by me against them. Finding no other alternative, I restrained myself from lodging any complaint. On 30.01.2020 at midnight 12 am my husband brutally assaulted me by kicking and had hit me with wooden stick resulting which I had sustained severe injuries. Thereafter on 30.01.2020 I was treated at Matigara BPHC. I didn't file any complaint as my husband had threatened me and my family with severe consequences.

That on 23.03.2023 at around 8pm my husband along with said Smt Priya Barik @ Smt Diksha Barik entered home. My husband in a conscious state started to abuse me with filthy languages before my children and in-laws. When I tried to protest, my husband and Smt Priya Barik @ Smt Diksha Barik punched my face, kicked and banged my head against the wall. My husband strangulated my neck tight leading me to death. Upon crying for help, my husband hit me severely in my left arm and banged my left elbow towards the wall resulting which I was severely

injured. My husband threw me down in the floor and severely kicked my left leg resulting into severe pain and black patches in my body. During the course of the said incident Smt Priya Barik @ Smt Diksha Barik snatched my mangulsutra with a gold locket which I was wearing and threatened me with dire consequences. My husband left no stone unturned to lead me to death.

Finding no other alternative, I am lodging this complaint before you against my husband and Smt Priya Barik @ Smt Diksha Barik and praying for proper justice towards me. I was unable to lodge the complaint immediately after the aforesaid incident as I was treated at Matigara BPHC on 24.03.2023 and I was suggested to take rest due to my head and body pain and injury. Kindly consider the same.
