Total of 5 times our cash box has been stolen from last year till this date. Our priest of the temple stays there, his is exposed to risk to his life in these situations. There has been a constant fear of loot in every now and then. At this point we are fearful of life if something more happens then just theft.

Here we express our deep concerns over the increasing theft in our mandir endangering lives. It would be of greater help if you could look through the matter and take relevant steps regarding this and stop this from happening.
