Sir,

In producing herewith one accused person namely 1. Shyamal Ch Biswas (M/55yrs) S/O- Lt Jiban Ch Biswas of Khola Chand fapri, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri along with following articles under proper seizure list-

1] 20 (twenty) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml)

I, PSI Koushik Raha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely Shyamal Ch Biswas (M/55yrs) to the effect that today on 27/03/2023 at 16.05 hrs while performing evening patrolling duty, received a source information that one person namely 1. Shyamal Ch Biswas (M/55yrs) S/O- Lt Jiban Ch Biswas of Khola Chand fapri, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri is selling liquor in his house situated at Khola Chand fapri, under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with force- C/915 C P Adhikary, CVF/-614 Sumit Roy, CVF /-935 Biplab Roy had been to Khola Chand fapri, Para under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source it found that one person was selling and storing liquor at his house. Subsequently, I along with my force cordoned the house and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the house. Further being searched the above noted seized articles were found in his house. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 06(six) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person Shyamal Ch Biswas (M/55yrs) after observing all sorts of formalities at the spot. The whole process of seizure has been made in between 17.15 hrs to 17.35 hrs at the spot. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against 1. Shyamal Ch Biswas (M/55yrs) S/O- Lt Jiban Ch Biswas of Khola Chand fapri, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
