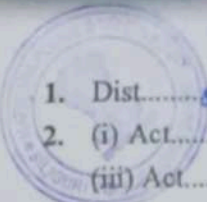

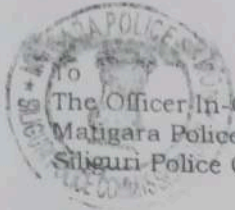

Sir,

In producing herewith 04 (Four) arrested accused persons namely (i) Prasanjit S/O- Bijoy Roy of Matigara Bazaar, PO+PS-Matigara, Dist.- Darjeeling (ii) Shiba Roy (2 Gopal Chandra Roy of Gas Godown near Darjeeling More, PS-Pradhannagar, Dist-I (Not verified) (iii) Md. Afzal (19), S/O- Md. Alam of Railgate Biswas Colony PO+PS- Dist.- Darjeeling and (iv) Krishna Biswas (32), S/O- Lt. Bimal Biswas of Biswas Colony ,PO+PS-Matigara,Dist-Darjeeling arrested u/s- 41 Cr.P.C along with following seize viz:

- (1)One iron made 'Knife' found from the possession of Prasanjit Roy which was kept in hand.
- (2)One iron made 'Crowbar' found from the possession of Shiba Roy which was kept in hand.
- (3)One iron made 'Bhojali' found from the possession of Md. Afzal which was kept on hand.
- (4)One iron made Hasua' found from the possession of Krishna Biswas which was kept in right hand.

I, SI Ager Lepcha S/O Dup Tshering Lepcha of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Prasanjit Roy (ii) Shiba Roy (iii) Md. Afzal and (iv) Krishna Biswas (32), on the effect that today on 28/03/2023 at 01:15 hrs received a source's information that a group of youths have assembled at Chandmoni Ground back side of Chandmoni Temple under the supervision of PS with a view to commit dacoity in a house at Uttorayan township area. Subsequently, after sharing the information with my superiors and as per their direction, I along with Subba, ASI Tapan Das, C/1053 Poresh Rava, C/974 Mintu Sen, and CV/643 Animes of Matigara PS, SPC, left for the place to work out the information. At about 01:20 hrs. reaching near Chandmoni Ground under PS- Matigara I met my source and being informed by the source we started walking towards Chandmoni Ground, back side of Chandmoni Temple. At 01:35 hrs. we reached at Chandmoni Ground, back side of Chandmoni Temple and cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the place. Seeing police personnel approaching towards them they tried to flee away but on being managed to apprehend above noted 04(four) accused persons along with seized items mentioned above. However, the other persons managed to flee away from the spot taking advantage of darkness. On interrogation all the accused persons admitted that they had assembled there to commit dacoity in a house at Uttorayan Township area.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house near Torayan Township area. It is also revealed from them that some others have assembled with them and planned for committing the dacoity.



Afzal (19), S/O- Md. Bimal Biswas of Biswas Colony PO+PS- Matigara, Dist.- Darjeeling and (iv) Krishna Biswas (32), Lt. Bimal Biswas of Biswas Colony Matigara ,PO+PS-Matigara, Dist-Darjeeling and others to be arranged for its investigation.
