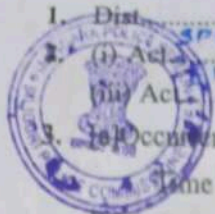

Dear Sir

It is to inform you that on 27.03.2023 at around 11:35 am, Electrical breakdown of the EMBEE FORTUNE 11 KV Feeder emanated from Shantiniketan 33/11 KV Substation, was reported to the undersigned. During feeder petrolling, it was found that the 11 KV 300 Sq. mm. 3 Core XLPE UG cable near the Entrance Gate of EMBEE DELIGHT Housing Complex, Durga Mandir, P.O. Kadamtala, P.S. Matigara, Darjeeling, was damaged during ongoing construction work of EMBEE DELIGHT Housing Complex.

Breakdown maintenance work has already been done by WBSEDCL for immediate restoration the power. WBSEDCL has incurred an estimated loss of Rs. 125342.00(Approx) for this damage.

Therefore, you are requested to look into this matter and take necessary actions. Please treat this as an FIR. Your early action in this regard is highly solicited.
