In producing herewith arrested persons namely (1) Rabin Roy (31) S/O Prasanna Roy of Bhotpara, Ambari, PS: New Jalpaiguri, Dist: Jalpaiguri along with one blue colour "Good Luck Classic" E- Rickshaw (without Registration Number) loaded with 04(four) numbers of 6mm iron rod (140 pcs) and 07(seven) pieces 3x3 inches iron pipes and (2) Latiful Rahaman (35) S/O- Rafizuddin Mohamad of Mahan Para, PS : Rajganj, Dist: Jalpaiguri with one red colour "E- Rickshaw (without registration Number) loaded with 28(twenty eight) pcs of iron profile, 14(fourteen) pcs of iron pati, 1(one) pcs of iron pipe, 1(one)pcs of iron angle, 2(two) pcs of iron zed angles.

I, SI Buddha Tamang, Officer In-Charge of Canal Road Traffic Outpost do hereby lodge a written complaint against the above named arrested persons to the effect that on 28.03.2023 from 12:00 hrs while performing motorcycle mobile duty at Ambari Falakata area found above noted E- Rickshaw (without Registration Number) carrying Iron rods, Iron pipes in hazardous condition defying the order of concern authority, which is dangerous to themselves and other road users and might invite fatal accident.

Accordingly I detained the above mentioned two e-rickshaw and its riders. On being interrogation they identifies themselves as (1) Rabin Roy (31) S/O Prasanna Roy of Bhotpara, Ambari, PS: New Jalpaiguri, Dist: Jalpaiguri and (2) Latiful Rahaman (35) S/O- Rafizuddin Mohamad of Mahan Para, PS : Rajganj, Dist: Jalpaiguri but they were unable to produce any valid documents in respect of their e-rickshaw and loaded iron rod and iron pipes and also failed to give any satisfactory reply for carrying such iron rods and pipes in hazardous condition through busy public road. As such I arrested them u/s 41 Cr.PC and seized E-rickshaws under proper seizure lists.

I therefore pray before you to start a specific case against the arrested persons under proper section of law and arrange for its investigation.
