Sir, in producing herewith One (01) Four Wheeler seized vehicle bearing registration no WB 73 6555 loaded with river bed materials.

I, SI Sailesh Subba of Matigara PS /SPC do hereby lodge this written complaint against the owner of the above noted accused persons namely to the effect that on 29.03.2023 I along with C/974 Mintu Sen while performing night mobile van duty PS area at about 22.10 Hrs received a source information that one vehicle loaded with river bed materials is coming towards Patiramjote from Rananagar Ghat under Matigara PS. Accordingly I, informed the matter to O/C Matigara PS and diarized the matter vide Matigara PS GDE NO: 1832, Dated 29.03.2023. And as per order of O/C Matigara PS, I along with force had been to Patiramjote to work out the source information.

At about 22.25 Hrs I accompanied with force reached at Patiramjote and hault the mobile van near Matrichaya, Patiramjote Road and waited for the said Vehicle. After sometime we saw one Vehicle Vehicle bearing registration no. WB 73 6555 coming towards us suspected to be loaded with river bed materials. I, gave the signal to the driver to stop the Vehicle. But seeing the Police party the driver flee away from the spot and left the vehicle at the site. I then checked the apprehended vehicle and found the loaded with river bed materials.

When the driver flee away from the spot after seeing the Police team there was strong reason to believe that the driver has procured the river bed materials from Rananagar Ghat illegally without any valid documents and has been transporting for clandestine disposal for his wrongful gain. Hence, I seized the above noted Vehicle bearing Registration No. WB 73 6555 along with loaded river bed materials under proper seizure list duly signed by available witnesses. The seizure was made in between 22.45 to 23.05 Hrs.

Under the above noted circumstances, I pray before your kind self that a specific case under appropriate penal section of Law may kindly be initiated against the driver and the owner of the Vehicle bearing registration no WB 73 6555 and arrange for its investigation.
