Prem Kumar Pradhan of Cutlary, PS Kurseong, District Darjeeling, beg to state that on 5/3/2023 in between 13:30 to 14:00 hrs while my son Prajwal Pradhan who was riding his bike No. WB-74-K/5161 near Pulse Hospital, Champasari, under Pradhan Nagar PS area, he was dashed by one red coloured Etios car bearing No. WB-06-G/4272, which was being driven by its driver very rashly and negligently. As a result my son received some grievous injuries. He was taken to nearby Pulse nursing home by the locals. His legs and hands are broken and his motorcycle also got damaged. He was later shifted to Mukta Nursing Home. He is still under treatment under doctors of Mukta Nursing home.

Necessary legal steps may kindly be taken against the accused driver.
