With due respect, I am producing herewith one arrested accused person namely Dulal Das (60) s/o Lt. Gour Chandra Das of Dakshin Shantinagar, Jabravita, PS- New Jalpaiguri, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 15 (Fifteen) bottle of 70 up Himalaya Fata Fati Country Spirit containing 300 ml in each bottle.
2. 04 (Four) Botle of Tuborg Strong Premium beer containing 650 ml in each bottle.
3. 03 (Three) bottle of Kingfisher strong premium beer containing 650 ml in each bottle

I, SI-Newton Biswas presently attached with NJP PS under your kind control beg to state that on 01.04.2023 at 0715 hrs I received a secret source information that one person namely Dulal Das (60) s/o Lt. Gour Chandra Das of Dakshin Shantinagar, Jabravita, PS- New Jalpaiguri, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at Dakshin Shantinagar, Jabravita under NJP P.S. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 10 date: 01.04.2023 and informed the fact to you. As per your kind direction and instruction myself along with HG/794 Ranjit Roy, CV/116 Rohit Kumar Mahato, VP/13 Jamirul Islam, CV/306 Biswajit Roy all of NJP PS, SPC left for Dakshin Shantinagar, Jabravita, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At 0745 hrs we arrived at Dakshin Shantinagar, Jabravita area under New Jalpaiguri PS, Dist.- Jalpaiguri and being identified by the source I held raid his shop where the above noted accused person selling ID Liquior. Accordingly as per the indication of Source I managed to apprehended him. On being asked he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his Shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his Shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 0815 hrs to 0845 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Dulal Das (60) s/o Lt. Gour Chandra Das of Dakshin Shantinagar, Jabravita, PS- New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.
