Sir,

In producing herewith one loaded vehicle viz: One Truck loaded with River Bed materials/Sands having Registration No- WB65/1695 under seizure in c/w above noted case.

I beg to report that, I SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar Police station under Siliguri Police Commissionerate lodge a written complaint against the owner and Driver of the above noted vehicle to the effect that today i.e. 02.04.23 at 14.10 hrs as per source information Myself along with SI Mrinal Basunia, C/1431 Dilip Barman, C/915 Chandra Prakash Adhikary all of Bhaktinagar PS had been to Dadabhai colony Shaktiman Ghat under Bhaktinagar PS (vide Bhaktinagar PS GDE No-71 dated 02.04.23) and found above noted vehicle loaded with illegal sands was started from Shaktiman Ghat at Dadabhai colony under Bhaktinagar PS. On chasing we apprehended the above noted vehicle but the driver of those vehicle fled away from the spot and on further checking the vehicle and found loaded with sand. Further, hence there was reason to believe that the driver of above noted vehicle had procured the loaded sand illegally and transporting the same for their illegal gain from Mahananda River.

On further grilling they procured the river bed materials, sand illegally from Shaktiman Ghat, Mahananda River and carrying/transporting the same to Siliguri side from river bed for their wrongful gain without any valid document. Under the circumstances, I seized the above noted vehicle along with loaded sand under proper seizure list in presence of local witnesses. The whole process of search, seizure took place in between 14.40hrs to 15.10 hrs.

Under the above, I pray before your kind end to start a case against the driver and owner of the seized vehicle viz:- WB65/1695 under proper section of law and caused its investigation.
