Subject: Complaint

I the undersigned Subhash Kumar Agarwal, Son of Late Gujarmal, Resident of M. G. Road, Post Office & Police Station : Jaigaon, District : Alipurduar, [Previously Jalpaiguri], like to state that I alongwith my brother Sri Prakash Kumar Agarwal and other close relative namely Sri Sunil Goyal, Son of Late Satya Narayan Goyal purchased two plots of land measuring 0.4029 Acres [24 Kathas 6 Chhataks and 32 Sq. Feet] and 0.135 Acres [8 Kathas 3 Chhatkas], appertaining to R S Plot Nos. 193 and 194 of RS Sheet No. 11 (Eleven) Mouza Dabgram under JL No. 2, corresponding to L R Plot Nos. 234 and 248 of LR Sheet No. 79 of Mouza Dabgram within the area of Bhakti Nagar Police Station, District : Jalpaiguri [West Bengal], for valuable consideration by virtue of two Deeds of Conveyances which executed and registered at the office of the District Sub Registrar, Jalpaiguri in Book No. I, being Deed Nos. 3873 and 3874 for the year 2005. It is stated that the said two plots of land were/are separately demarcated and bounded by pucca brick built up wall with RCC Pillars in all sides and that there is one Katcha Road measuring 12 Feet in breadth in between the said two plots of land. It is stated that there are two iron sheet gates with padlocks fitted with pucca boundary wall in big size plot of land and one iron sheet gate with padlock fitted with pucca boundary wall in small size plot of land and that there is one tin -shed structure prepared over the said plots of land and that one electric connection/meter as provided by the electric department in my name is also running/maintaining in the said tin shed structure since a long back periods. The said plots of land were/are also looked after by the local care

taker/security services in the name of Lokenath Security Services of Chayan Para, Ghogomali, Eastern Bypass, Ashigarh More, Siliguri represented by Sri Chitta Ranjan Sarkar.

Sir, it is stated that on 01.04.2023 at about 2.00 PM, my elder brother Sri Prakash Kumar Agarwal, received a phone call in his mobile No. 94344-89911 from the said care taker Sri Chitta Ranjan Sarkar that some miscreants have forcefully entered in my/our said small size plots of land measuring 8 Kathas 3 Chhataks together with one van rickswa loaded with some bricks, sand, bajari and cement, by breaking the pad lock and have started to evacuate the land/earth in middle portion of the said plots of land with an intention to construction make pucca dhalai in the said plots of land to encroach upon our said plots of land illegally and wrongfully and also with dishonest and fraudulent intention. And when my said care taker obstructed the said miscreants, in evacuating the land, then they become furious and abused in filthy language and threatened with dire consequences. As a result of which, my said care taker apprehended the danger of his life from the hands of the said miscreants and fled away from the spot/said plots of land. And on receipt of the said phone call, my said brother arranged to intimate the police station through his representatives. On arrival of police, the said persons fled away from the said spot and took back their said construction materials with their said van rickshaw. Subsequently, I got the information that the said persons were headed by local land broker/land mafia namely Nitai and Nitto Gopal Das. I have also come to know that some other persons were/are also involved in this incident. Thereafter, I went to my said plots of land and found that the said miscreants have stolen one vibrator machine valuing Rs.10,000/= approx from my said plots of land. The said miscreants have trespassed in my/our said plots of land, illegally and forcefully along with their van rickshwa and damaged my plots of land by evacuating the land with in intention to grab my

said plots of land and stolen the vibrator machine and threatened with dire consequences and committed the offence punishable under the law.

In view of the above, I therefore, requests your good office to be kind enough to book the said persons for investigation into the matter and arrange to punish the culprits as per law.
