Sir,

In producing herewith one accused person named Joymani Malpaharia (F/45 years) W/O Sri Manoj Alam of Pabitra Nagar, Galli No. 03, PS Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure.

1. 18 (Eighteen) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 10.8 liters)

I, SI Abhishek Theengh of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person namely Joymani Malpaharia (F/45 years) W/O Sri Manoj Alam of Pabitra Nagar, Galli No. 03, PS Pradhan Nagar, Dist. Darjeeling to the effect that today on 04.04.2023 at 15.10 hrs. received a source information that one lady has been selling huge quantity of illicit liquor without any valid license at Pabitra Nagar, Galli No. 03 under Pradhan Nagar PS.

Accordingly, I informed the matter to your good notice and as per your kind direction I along with ASI Manoj Kumar Roy, LCV//356 Sangita Dusad, CV/646 Baban Das, CV/242 Rakesh Mangar had been to Pabitra Nagar, Galli No. 03 under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that one lady at her house was selling illicit liquor to the customers illegally for her wrongful gain. Subsequently, I along with my force cordoned the house and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed her name and identity as mentioned above.

Further being searched the above noted seized articles were found in house from her possession. On demand she failed to produce any valid license/papers for the articles which was recovered from her possession. On further interrogation she stated that she was involved in selling and possessing of liquor without any valid license for last 06 (six) months for her illegal gain. Then I seized and labeled the above mentioned illegal illicit liquors under proper seizure list in presence of witness, LCV/365 Sangita Dusad and arrested the above-mentioned person named Joymani Malpaharia (F/45 years) W/O Sri Manoj Alam of Pabitra Nagar, Galli No. 03, PS Pradhan Nagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 16.15 hrs to 16.48 hrs at the spot and arrested her after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Joymani Malpaharia (F/45 years) W/O Sri Manoj Alam of Pabitra Nagar, Galli No. 03, PS Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
