In producing herewith one arrested accused person namely Rash Mohan Biswas-55yrs s/o Lt Ramdeb Biswas of Gozole doba No-10 PS Gazoledoba, Dhumsigara, PS Malbazar, Dist along with seized articles viz:- one loaded Damper having Registration No-WB73D/9140 loaded with River Bed materials/Sands.

I SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar Police station under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that today i.e. 03.04.23 at 12.20 hrs during my PS mobile duty vide Bhaktinagar PS GDE No-109 dated 03.04.23 had been to Bhaktinagar Gourangapally, Haiderpara ward no-40 and found one loaded Damper loaded with sands was standing there with loaded sand. On checking myself along with SI Mrinal Basunia, ASI Dipak Karmakar, C/1431 Dilip Barman, C/915 Chandra Prakash Adhikary all of Bhaktinagar PS apprehended that vehicle along with its driver and on further checking the vehicle and found the Damper loaded with sand. On demand, the driver of the Damper disclosed his name and identity as noted above. Further, on demand the driver of the Damper failed to produce any valid documents related to the Damper as well as the loaded River Bed materials/ sand in the vehicle. Hence there was reason to believe that the driver of the Damper has procured the loaded sands illegally and transporting the same for their illegal gain from Gazoledoba.

On further grilling he disclose that he has procured the river bed materials, sand illegally from Gozoledoba and carrying/transporting the same to Siliguri side from river bed for their wrongful gain without any valid document. Under the circumstances, I seized the loaded Damper having number plate no- WB73D/9140 along with loaded sands under proper seizure list and arrested the driver of the Damper under proper Memo of Arrest after explaining the reason of arrest to him in presence of local witnesses. The whole process of search, seizure took place in between 12.40 hrs to 13.25 hrs.

Under the above, I pray before your kind end to start a case against the above arrested person namely Rash Mohan Biswas-55yrs s/o Lt Ramdeb Biswas of Gozoledoba No-10 PS Gazoledoba, Dhumsigara, PS Malbazar, Dist Jalpaiguri and its owners under proper section of law and caused its investigation.
