With due respect I, **FATEMA KHATUN**, Daughter of Late Dildar Hussain, resident of Gital Para, Iskon Road, Ashraf Nagar, Ward No.40 of S.M.C., Siliguri, P.O. Haiderpara, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to lodge this Written complaint before your good office to the effect we are three brothers namely (1) Md. Idrish Hussain, (2) Md. Farid, (3) Md. Noor and three sisters including myself, Ajmeri Khatun and Amina Khatun and I am the youngest daughter of my parents and save and except myself, all of my brothers and sisters are married and my elder sisters have been residing at their respective matrimonial house since the date of their marriage. It is to be mentioned here that our father has already expired since 5/6 years ago and after the demise of our father, the health condition of our mother has been deteriorating day-by-day.

KHATUN, Wife of Late Dildar Hussain, is the absolute and exclusive owner of all that piece or parcel of land measuring 2 Kathas and 3 Chhataks, appertaining to and forming part of L.R. Plot No.47, recorded in Khatian No.04, of Mouza - Dabgram, J.L. No.02, Pargana - Baikunthapur, situated within the jurisdiction of Police Station - Bhaktinagar, Dist. Jalpaiguri, together with a tin shaded pucca structure measuring about 650 Sq.ft. and after purchasing the said property, my mother has been possessing and enjoying the aforesaid property in her actual khas and physical possession, having right, title and interest therein, free from all encumbrances and charges whatsoever and presently, in the property of our mother, my elder brother namely Md. Farid and his family members including my mother and myself have been residing there.

Since last few months back, our mother as per the desire of my brothers have decided to sold out a portion of her aforesaid property with respect to land measuring 962 Sq.Ft. to Nilu Siddique, W/o Abdul Mannan, Daughter of Md. Sikander Siddique @ Sohail Siddique, by virtue of Deed of Sale being No.I-2766, dated 12/10/2022.

That I have several time requested to my brothers for get back the above amount to me but they said that they could not returned this above amount to me because the unnecessary reason.

It is further hereby mentioned that on 26.03.2023 near about 9. P.M. my brother Md. Farid and his wife Fatema Khatun, Md. Idrish Hossain and Amina Khatun came to my rental house and abuse me with filthy and offensive language and assault me mercilessly and threatened me with dire consequences and my brother namely Md. Farid and Md. Idrish Hossain was make one forged agreement document along with my signature that they have returned this said amount to me and above incident said Fatema Khatun Wife of Md. Farid and Amina Khatun wife of Md. Ghulam Qadir influence to my above said brother for not provide the money to me.

Sir, I am unmarried lady, having no source of income of my own and still now, I have been studying and also providing tuition to the students from my rental house and out of the small income, I have been maintaining myself as well as incurring expenditure towards my studies.

That it is further hereby mentioned that my brother Md. Farid and his wife Fatema Khatun, Md. Idrish Hossain and Amina Khatun have committed the offences Criminal Conspiracy, Voluntarily causing hurt, Wrongful restraint, Criminal Breach of trust, Cheating, House trespass, Forgery for the purpose of cheating, Genuine a forged document, Criminal intimidation against me.

So Sir under the above circumstances I am passing my days with great fear and anxiety.

I, therefore, request you to look after the matter and please take strong legal steps against my said brother Md. Farid and his wife Fatema Khatun, Md. Idrish Hossain and Amina Khatun as early as possible as per the provision of law and obliged thereby either I will suffer irreparable loss and injury.
