This has resulted in the damage of PCC Pole, Iron fitting, insulators and ACSR conductors. Power interruption has occurred in the localities resulting in grievance of common people. The Total Damage incurred was Rs. 16,871 /- only (Sixteen Thousand eight hundred and seventy one).
