Sir,



Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Sumit Das S/o Khokan Das of Subhash Pally, Netaji High School, Siliguri ,Dist- Darjeeling. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.


Therefore I would request you to kindly start a specific case in terms of Section of 188/283 IPC and other sections of law as deemed fit against the said person with necessary action as applicable.
