Sir,

With due respect and humble submission, in producing herewith one accused namely Sajam Sunam (32years) S/O Sri Madan Sunam of Utpal Nagar , Road No.2,P.s-Pradhan Nagar,Dist.Darjeeling under arrest along with following articles under proper seizure ;

- i) 10(Ten) Plastic bottles of Himalayan Gold 60 up ,India made Liquor , each bottle containing 600 ML, (Total 6 Ltrs) .

I ASI Ashit Singh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 06.04.2023, I was engaged mobile van duty vide Pradhannagar PS GDE No. 355 dtd.06.04.2023 along with C/762 Mojibul Rahaman and CV/242 Rakesh Mongar all of Pradhannagar P.S , during mobile duty at 15.05 hrs. I received an information one person namely Sajam Sunam storage huge quantity of illegal liquor in his hotel at Siliguri Junction near Delhi Hotel and selling the same . Accordingly I informed to you and as per your direction myself along with force held raid and found that he is selling the liquor openly from his hotel , then I detained the above noted person and on being search recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 15.25 hrs to 15.55 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Sajam Sunam (32years) S/O Sri Madan Sunam of Utpal Nagar , Road No.2,P.s-Pradhan Nagar,Dist.Darjeeling and arrange for its investigation.
