As directed and as per the site inspection report received from Sri Debabrata Das (Cell No. 9434354497) and Sri Dhruba Jyoti Roy Dakua (Cell No. 9749365186), Sub-Assistant Engineers of Siliguri Municipal Corporation, this is to inform you that both above-mentioned SAEs reached the site located alongside Pati Colony, Road No. 02, Ward No. 47 of Siliguri Municipal Corporation for causing the inspection on 25.03.2023.

As reported, they were restrained from entering into the site by Smt. Mita Majumder. They repeatedly requested to allow them to cause the inspection but roughly attended. Even Smt. Mita Majumder & one person who over telephone categorically mentioned that they would not stop the ongoing construction at any cost, whatever be the consequences(enquiry report attached).

It is further to mention here that 02(two) notices bearing memo no. 169/SMC/N/Bldg/2022-2023, Dated 10.11.2022 and memo no. 191/SMC/N/Bldg/2022-2023, Dated 27.12.2022 were issued by the Commissioner, Siliguri Municipal Corporation whereby Smt. Mampi Dutta (Bhattacharya) & Ors. were directed to stop the ongoing construction and to appear before the Commissioner, Siliguri Municipal Corporation for hearing which have not been complied with till date.

I am again to inform you that 01(one) FIR was also lodged against Mampi Dutta vide this Office memo no. 338/SMC/G, Dt. 11.01.2023.

Therefore, you are requested to lodge a General Diary against the miscreants and take necessary action as per law.

Site Inspection Report

Pursuant to a complaint vide letter docket no.19426 dated 14.03.2023 by Smt. Minu Paul, an inspection at the site in question was conducted by us i.e. Sri Debabrata Das & Sri Dhruba Jyoti Roy Dakua, the sub-assistant engineers of SMC. Such inspection was caused on order by the Commissioner, SMC.

It is pertinent to point out herein that when we reached the site in question for causing the inspection on 25.03.2023, we were restrained from entering in to the site by Smt. Mita Majumder. On repeated request made by us to allow us to cause the inspection we were roughly attended. Even Smt. Mita Majumder & one person who over telephone categorically mentioned that they would not stopped the ongoing construction at any cost, whatever be the consequences.

On early occasions 2(two) notices bearing memo no.169/SMC/N/Bldg/2022-2023 dt. 10/11/2022 & memo no.191/SMC/N/Bldg/2022-23 dt. 27/12/2022 were issued by the Commissioner, Siliguri Municipal Corporation, whereby Smt. Mampi Datta (Bhattacharya) & others were directed to stop the ongoing construction & to appear before the Commissioner, SMC for hearing. Such notices bearing memo no.169/SMC/N/Bldg/2022-23 dt. 10/11/2022 & memo no.191/SMC/N/Bldg/2022-23 dt. 27/12/2022 have however not been complied with till date.





