married to him 7 December 2020. It was
my social marriage in front of his
family. Since after a year I gave a
birth to baby girl. Even I was abused
by Mother for conceiving a girl child.
After that my relation deteriorated with
my husband. After I gave birth to girl
since then he abused me on the
other way having external affair
and he started using prostitutes for

his greedy needs. He knows about my home address and out going schedule and he doesn't miss and chance to harass me. One day fine night he came to my place knocking the door. I was with my 8 month baby in room. He came inside and directly abused me sexually. After a month I came to know that I was pregnant. I was willing to keep that baby but he enforced me to abort (Hence I have the proof).

Sometimes he used to come and ask me money and my Jewellery. If I would deny giving so then he used to give us a condition and otherwise he used to torture me physically (Hence I have the proof) and I am being forced to file divorce. Property ^{are being} transferred to his family.

He assaults me with various sexual abuse and goes for pornography with other prostitute women.

I request you to kindly apply him rigorous imprisonment for a term which may extend to three year or couple of year
