Sir,

With due respect, I am producing herewith 02 (two) arrested accused person namely 1. Pojir Hussain (20) S/O Lt. Habibar Hussain of Paschim Dhantala, P.S- N.J.P, Dist.- Jalpaiguri and 2. Ranjit Thapa (22) S/O Surya Thapa of Paschim Dhantala, P.S- N.J.P, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with them.

1. One TATA AC vehicle having Reg. No. WB 73 G 5470 containing 02 (two) barrel of raw spirit, each barrel containing 200 liters, total 400 liters.

I, ASI-Khagen Barman presently attached with NJP PS under your kind control beg to state that on 05.04.2023 at 20.15 hrs I received a secret source information that one one TATA AC vehicle having Reg. No. WB 73 G 5470 was coming from Ghoshpukur area with huge contity of illicit raw Spirit. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 224 date: 05.04.2023 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 laxman Roy, VP/13 Jamirul Islam, CV/824 Niru Yadav all of NJP PS, SPC left for Fulbari Toll gate, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At 20.45 hrs we arrived at Fulbari Toll gate under New Jalpaiguri PS, Dist.- Jalpaiguri and being identified by the source apprehended one TATA AC vehicle having Reg. No. WB 73 G 5470 which was matched with source information. We found one Pojir Hussain was driving the said TATA AC vehicle and one Ranjit Thapa was found at beside driver seat. After being interrogation they disclosed their identity as noted above. On search the above noted 02 (two) barrel of raw spirit, each barrel containing 200 liters, total 400 liters was recovered from the TATA AC vehicle having Reg. No. WB 73 G 5470. On demand he failed to produce any documents/licence in respect of said illicit raw spirit as well as said vehicle. Accordingly, I seized the above noted TATA AC vehicle having Reg. No. WB 73 G 5470 containing 02 (two) barrel of raw spirit, each barrel containing 200 liters, total 400 liters under proper seizure list and arrested them under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 21.55 hrs to 22.35 hrs on 05.04.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely 1. Pojir Hussain (20) S/O Lt. Habibar Hussain of Paschim Dhantala, P.S- NJP, Dist.- Jalpaiguri and 2. Ranjit Thapa (22) S/O Surya Thapa of Paschim Dhantala, P.S- NJP, Dist.- Jalpaiguri and arrange for its investigation.
