Respected Sir,

I Suraj Tamang, SSE/E/CON/NJP would like to draw your attention towards a theft that happened at SSE/E/CON/NJP's Store. There are 3 Nos. Store Godown at the SSE/E/CON/NJP's office premises which contains electrical items. The thieves broke the lock of one of the Godown and stole all the PVC Copper Cable of different sizes 16 Sqmm (6000Mtr) & 1.5 Sqmm (6000Mtr) which is a big loss for the Railway Department as well as a risk factor for our office as we have other electrical items like transformer, pole, insulators, panels etc in the premises. The Godown is last opened on 13/03/2023 at 2.00PM and we came to know about the theft on 05/04/2023 at 10.30am in the morning. The Thieves even replace the old lock and installed new lock at the Godown.

Please treat this note as an official complaint, and record it in the F.I.R. Please acknowledge receipt of this complaint, quoting the F.I.R. number with date assigned to it.
