Our security informed us that 7 dialysis machines were taken out from the hospital through the basement route on 4th April 2023 by M/s Nephro Health Services Pvt Ltd.

On inspecting our Dialysis Center, which is run by M/s Nephro Health Services Private Ltd, under a definite service agreement and an equipment usage agreement dated 21st June 2019, it was found that 7 no of Hemodialysis machine which was owned by us and used by M/s Nephro Health Services Private Ltd was found missing from the premises. Such act on their part have resulted in breach of trust to our agreement as the same has been removed without our consent.

We request you to kindly investigate the matter and take appropriate legal action the concerned.


