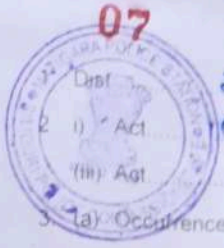

Sir,

I, **Smt. Anita Mohanta** wife of **Sri Ananta Mohanta**, resident of **Ranadip Colony, Patiram Jote, P.O. and P.S. Matigara, District- Darjeeling**, with extreme anguish would like to inform you that I along with my husband are being regularly tortured both physically and mentally and being insulted and abused with filthy languages by our son **Sri Nilkamal Mohanta** and our daughter-in-law **Smt. Rina Mohanta** alongwith **Pratima Debnath** daughter of **Suresh Debnath of Phansidewa, Kalidas Roy , Ranjana Roy** both resident of **Mohit Nagar, Jalpaiguri** on the demand of transfer of our residential house in the name of son and daughter-in-law.

Whenever I and my husband objected against such tortures by them, we were threatened of being killed. On 27.04.2022, 14.05.2022 and thereafter on several occasions we have been assaulted by our son and daughter-in-law with fist and blows. My son strangulating my throat even threatened me to transfer the house to him otherwise he will kill me. In one occasion my daughter-in-law kept the nozzle of the gas cylinder open in my kitchen so that she kill me under the veil of fire accident. They tried to drove me and my husband out of our house forcefully to grab the house. I have filed several complaints to your police station informing you about the aforesaid incidents, but none of my complaint was registered. Photocopies of such complaints are annexed herewith which are self-explanatory in nature. Every now and then they are threatening us that they will grab my house at any cost. If required, they will kill me or will put me in jail to grab the house. They have also threatened that no police will pay any heed to my tears as they are having good nexus with them.

In such a situation my daughter-in-law as part of criminal conspiracy hatched with my son and **Pratima Debnath, Kalidas Roy** and **Ranjana Roy** lodged a false complaint against me, my husband, my daughter and my son-in-law with an intention to put us behind the bar so that they can grab my house forcefully and to harass my married daughter and son-in-law to create a undue pressure upon us to withdraw the application before the **SDO, Siliguri** and transfer the residential house in their name. However, the **Ld. Court** has enlarged us on bail.

Now my son and daughter-in-law are threatening me with dire consequences if I do not transfer my house immediately to them. I am extremely scared and worried about the safety and security of lives and property of me and my husband. I apprehend




that at anytime my son and daughter-in-law alongwith their accomplices Pratima Debnath, Kalidas Roy and Ranjana Roy may kill me and my husband.

Under the aforesaid situation I request you to take immediate action to save the lives and properties of me and my husband and to punish my son, daughter-in-law and their accomplices Pratima Debnath, Kalidas Roy and Ranjana Roy as per law.
