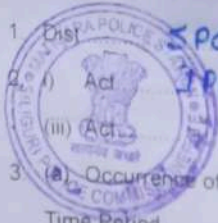

Sir,

With due respect and in producing herewith the arrested accused person namely Nayamussin Ali (45), S/O Kalu Mohammad of Matigara Bhangapool, PS - Matigara, Dist- Darjeeling with following seized articles :-

- One vehicle Tata Truck bearing Reg. No. WB - 73 B 6828 Loaded with river bed materials.

In this regard, I ASI Dharendra Nath Mandal of Matigara P.S, SPC do hereby lodge this Complaint against above noted arrested accused person to the effect that on 06.04.2023 at about 16:05 hrs onwards I received a source Information that one vehicle one vehicle Tata Truck bearing Reg. No. WB - 73 B 6828 loaded with river bed materials coming from Parimal Nagar Ghat side without any valid documents. Accordingly I inform the fact to Officer In charge, Matigara PS and as per his kind direction myself along with force had been to Parimal Nagar under PS Matigara to work out the information in hand. After arrival of the spot, I found said vehicle Tata Truck bearing Reg. No. WB - 73 B 6828 loaded with river bed materials standing at Parimal Nagar near Matri Chaya under Matigara PS area. Accordingly, I apprehended the driver of the vehicle. On demand he failed to produce any valid documents in respect of river bed materials loaded in his vehicle. On further interrogation, he stated that he mines such river bed materials from Parimal nagar Ghat by illegal means with a view to sell the same for his illegal gain. Accordingly, I seized the above noted vehicle loaded with illegally mining river bed materials under proper seizure list and arrested him after maintaining all formalities regarding arrest.

Therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Nayamussin Ali (45), S/O Kalu Mohammad of Matigara Bhangapool, PS - Matigara, Dist- Darjeeling or the owner of the vehicle and arrange for its investigation.
