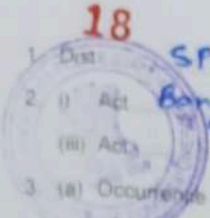

Sir,

With due respect I am submitting a written complaint against one accused person namely Raj Kumar Biswakarma (51) s/o Late Prithilal Biswakarma, Mohamaya Colony, PO+PS- Matigara, Dist.- Darjeeling along with the following articles under proper seizure list viz;

1. Twenty (20) Bottles of "KINGFISHER STRONG PREMIUM BEER" each Bottle containing 650 ml [Total 13 Litres] and marked as Exhibit "A" out of which 01 (One) bottle of "KINGFISHER STRONG PREMIUM BEER" each Bottle containing 650 ml. taken as sample for examination and marked as Exhibit "A-1".
2. Seven (07) Bottles of "60 UP PET HIMALAYAN GOLD COUNTRY SPIRIT" each Bottle containing 600 ml. [Total 4.2 Litres] and marked as Exhibit "B" out of which One (01) Bottle of "60 UP PET HIMALAYAN GOLD COUNTRY SPIRIT" containing 600 ml. taken as sample for examination and marked as Exhibit "B-1".
3. Six (06) Pet Bottles of "MCDOWELL'S NO1 CELEBRATION MATURED XXX RUM" each Bottle containing 180 ml [Total 1.08 Ltrs] marked as Exhibit "C" out of which 01 (one) Pet Bottle of "MCDOWELL'S NO1 CELEBRATION MATURED XXX RUM" each Bottle containing 180 ml. taken as sample for examination and marked as Exhibit "C-1".

I, SI Agen Lepcha of Matigara P.S, SPC would like to lodge this written complaint against the above noted accused namely Raj Kumar Biswakarma (51) s/o Late Prithilal Biswakarma, Mohamaya Colony, PO+PS- Matigara, Dist.-Darjeeling to the effect that today on 07.04.2023 at about 20.50 hours I received a specific source information that the above noted accused person is selling illicit liquor at his house situated at Mohamaya Colony under Matigara PS. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 367, Dated 07.04.2023 and informed the fact to the Officer-In-Charge, Matigara PS and as per his kind order and direction myself along with ASI Tapan Das, C/974 Mintu Sen, and CV/643 Animesh Roy all of Matigara PS left for Mohamaya Colony to work out the information in hand. At around 21.05 hours we arrived at Mohamaya Colony and called two independent witnesses namely 1. Arjun Biswakarma s/o Ram Bahadur Biswakarma of Bagdogra, Birsingh Jote, P.O+P.S Bagdogra, Dist. Darjeeling and 2. Golak Barai s/o Lt. Bhim Barai of Simultala, PO+PS-Matigara, Dist-Darjeeling and shared the information in hand to them. I called the source to identify the house of said person and being pointed and identified by the source I along with accompanied team entered into the house of said Raj Kumar Biswakarma and soon after seeing the police team he managed to flee away from the spot.

Being identified by the source I, then along with accompanied team searched his house in presence of witnesses and recovered the above noted seized articles from the house of said Raj Kumar Biswakarma which was kept concealed below the bed inside one room of his house.

FIRST INFORMATION REPORT

On enquiry to the local witnesses it could be learnt that the house belongs to Raj Kumar Biswakarma (51) s/o Late Prithilal Biswakarma, Mohamaya Colony, PO+PS- Matigara, Dist.-Darjeeling and he has been selling illicit liquor at his house since long without any valid license for his wrongful gain. Then, I seized and labeled the above mentioned liquor under proper seizure list. The whole process of seizure and label has been made on 07.04.23 in between 21.25 hrs to 21.55 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against arrested accused namely Raj Kumar Biswakarma (51) s/o Late Prithilal Biswakarma, Mohamaya Colony, PO+PS- Matigara, Dist. Darjeeling and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
