In producing here with six arrested accused persons namely (1) Sahabuddin Khan-36yrs s/o Jafaruddin Khan of Mohalla Ban Mandi, Parikshitgarh, Merut Uttar Pradesh-250001 (2) Danish (M/22yrs) s/o Irfan of Agwanpur, PS Kila Dist Merut UP-250406 (3) Majid (M/26yrs) s/o MatMatlub of Mohalla Mandi, Parikshitgarh Mawana Merut UP -250406 (4) Rakesh Kumar Sahani-22yrs s/o Suresh Sahani of Sikandarpur Kundal PS Muzaffarpur Town Bihar ((5) Md Amanna-25yrs s/o Md Jafruddin of ward no-12 House No-450 Harpur Lahauri MIT Muzaffarpur Bihar and (6) Sajjat Hussain-23yrs s/o Md Basir of Khalpara Vivekananda Road Siliguri Bazar ward No-7 PS Siliguri Dist Darjeeling along with seizure articles viz.-

- 1] 240 (Two hundred forty) no's of (07 liters) MILTON premium pressure cooker
- 2] 60 (Sixty) no's of Surya Spark & Blaze Induction Cooker
- 3] 150 (One hundred fifty) no's of RICH ROYAL SURYA L.P Gas stove
- 4] 240 (Two hundred forty) pieces of RADIX 12 volt battery
- 5] 12 (Twelve) no's of TooT-An Ceiling Fan
- 6] One white colour Truck (Ashok Leyland) having registration No- UP15GT/1301, Engine No- PNEZ400503 & Chassis No-MB1AZHCD4PANN5747

I SI Rantu Haldar of Bhaktinagar Police station under Siliguri Police Commissionerate lodged this written complaint against the above mentioned persons. I beg to report that on 07.04.23 at about 12.15 hrs received secret source information from Ektiasal Battala Pradhan More under Bhaktinagar PS that huge numbers of stolen utensils of reputed company (Pressure cooker, Fan, Induction oven e.t.c) have gathered by some persons and concealed their rented house after procured the same from Delhi for selling the same in Siliguri area for their wrongful gain. Accordingly the information was diarized vide BKN PS/SPC GDE No. 310 Dated 07.04.23 and informed to I/C Bhaktinagar PS/SPC about this information. As per kind order of I/C Bhaktinagar PS/SPC myself along with SI Mrinal Basunia, ASI Dipak Karmakar, PSI Koushik Raha, C/374 Debraj Biswas, C/1431 Dilip Barman, C/915 Chandra Prakash Adhikary, all of Bhaktinagar PS/SPC left PS to verify the veracity of information vide Bhaktinagar PS GDE No-311 dated 07.04.23 . We reached at Ektiasal Battala, near Pradhan More and as per showing and identified my source and detain one half loaded Truck having Registration no-UP15GT/1301 found that three persons unloading the above noted articles from the Truck and gathered their rented room and rest three are the driver & Khalashi of the above noted vehicle. On interrogation they admitted that all the articles brought from Delhi for selling purpose after using the Brand of reputed company and cheated the general public for their illegal gain. On asking they are disclosed their name and address as noted above and made some incoherent talks

and became perplex. On demand they failed to give any documents in respect of the above noted articles. On being questioned they could not give any satisfactory account, moreover they made some contradictory statement which is reason to believe that they procured the articles by fraudulent means or stolen from anywhere. Hence seized the articles after preparing proper seizure list in presence of witness namely (1) Nabanu Roy-53yrs s/o Lt Parganath Roy of North Ektiasal, Puratan Battala, PO Sevoke road PS Bhakinagar Dist Jalpaiguri and (2) Mithu Roy-34yrs s/o Chandra Mohan Roy of North Ektiasal Battala, PO Sevoke road, PS Bhaktinagar Dist Jalpaiguri (Seizure was made in between 13.10hrs to 15.10 hrs) and arrested the persons u/s 41 Cr.pc.

I therefore pray that a specific case may kindly be started against accused persons (1) Sahabuddin Khan-36yrs s/o Jafaruddin Khan of Mohalla Ban Mandi, Parikshitgarh, Merut Uttar Pradesh-250001 (2) Danish (M/22yrs) s/o Irfan of Agwanpur, PS Kila Dist Merut UP-250406 (3) Majid (M/26yrs) s/o MatMatlub of Mohalla Mandi, Parikshitgarh Mawana Merut UP -250406 (4) Rakesh Kumar Sahani-22yrs s/o Suresh Sahani of Sikandarpur Kundal PS Muzaffarpur Town Bihar ((5) Md Amanna-25yrs s/o Md Jafruddin of ward no-12 House No-450 Harpur Lahauri MIT Muzaffarpur Bihar and (6) Sajjat Hussain-23yrs s/o Md Basir of Khalpara Vivekananda Road Siliguri Bazar ward No-7 PS Siliguri Dist Darjeeling under proper section of law and arrange for its investigation.
