I Nidam Shespa D/o Passang Shespa of Nathula
Villa Apartment Flat No 3B, Pradhanagar, near Masjid w/N
45 PS Pradhanagar District Darjeeling. would like to
State that I am a lady Sub-Inspector of Police
west Bengal presently posted at Bhaktinagar PS
Under Siliguri Police Commissionerate. I was married
to Paras Mani Rai s/o Santosh Mani Rai of
Utpalnagar, 3 by lane, w/N 46 PS Pradhanagar
District Darjeeling. on 20/09/2020. He is an Indian
Army and posted at Jabalpur Madhya Pradesh.
Since after the marriage he had been harassing
me and torturing me. but out of family
prestige I never complained. Due to his day
and night torture I started to decide separately
and have been presently residing with my
father. On 6/04/2023 I came to learn that
he has come to Siliguri on leave. Today I
went to Nathula villa flat to handover his
belongings with my sister and her inlaws, as
he demanded me to return his clothes.
But after reaching flat he started harassing
me and my young sister inside the flat. at 11:30
he also tried to attack me with
sharp weapon but my brother in law came to
rescue and other people of the society also
when I started screaming. he locked me
the flat and was not letting me go

out. He has been forcing me to stay with him. and when I denied then he started alleging me of having extra affairs with my staff and other superiors. All his activities have been hampering my professional life too. He is also trying to spoil my reputation. When he was stopping me from going out. at that time my younger sister called Pradhan Nagar P.S and after their arrival I was rescued..

Sir, I would like to further narrate that he always ~~assaulted~~ insulted me, ~~but~~ and dominated me. I had also submitted a written information against him on 02/03/2023 over which I had mentioned that I did not want to start any specific case but his today's activity ~~to~~ compelled me to lodge this complaint. At present when I denied to stay with him, then he started to spoil my character by giving false allegation. I have also consulted with my family and lawyer regarding the divorce process. He is a Army person by profession but he comes on leave every month & harasses me & insults me and tries to assault me.

I request you to take a strong action against him as per law. Also to mention that my flat located at Pradhan Nagar is under lock & key and he may forcefully try to enter the said flat.
