Re: Sonu Kumar my office staff , (service tenure 10-12 days) ran away taking RS. 160000 (one lakh sixty thousand), from barduwan road howrah petrol pump bus stand.

Respected sir,

I Adarsh Choudhury son of Ratan Choudhury, residing at Choudhury House , Nehru road – 734005 being CEO of the company R B Trade wings Pvt Ltd, want to launch a FIR of undermentioned incidents.

I Had employed one staff on or about 22nd March namely Sonu Kumar , son of Mr. Indrajit Patel , residing bhelva , Manpurwa , East Champaran Bihar – 845420 (ID enclosed), living in siliguri in a rented property near guwala patty barduwan road . On 6-04-2023, I had sent two staff one Mr. Khaniya Paswan our old staff residing at diesel colony ward no 1 and Mr. Sonu Kumar for collection of money from debtors in (Chopra , Lalbazar Daspara and sonapur areas). On returning from (Chopra , Lalbazar Daspara and sonapur areas), Mr Khaniya Paswan gave the bag containing the collection from debtors of Rs 1,60,000 (one lakhs sixty thousand) along with papers, books and collection receipt to Mr. Sonu Kumar on or about 16:40 hours at the urinal at Burdwan road Howrah petrol pump bus stand before going to urinate.

Khaniya Paswan on returning from urinal did not find Sonu Kumar whereabouts and reported me immediately the facts stated in this letter.
