Dear Sir,

With due respect I the undersigned would like to inform you that ^{today} in the evening at about 08:15 p.m. I along with one Sri Amit Mandal was going by my four wheeler being registration no. WB 74 BC 4003 and when I was crossing the Bidhan Market Murgi Hati, one motorcycle being registration no. WB74 BG 3009 and its rider and one pillion rider was coming from opposite direction and made the sudden break in front of my vehicle and I requested the said rider to give me a pass as I could go forward but the said rider has started to misbehave with me and he asked me to come out from my vehicle and ultimately I was compelled to come out from my vehicle and after that he introduced himself as a renowned lawyer of Siliguri Court namely Sutirtha Raha and he told me that he will see me at Siliguri Court tomorrow. Due to such illegal activities of said rider I protested the same and he rushed to my friend and when I tried to resist him, he pushed me on my chest intentionally and abused filthy languages which cant not be uttered in the civilized society.

I would like to further inform you that in the mean time said rider snatched the key of my vehicle and badly damaged the same and he called so many persons over his cell phone and 15 to 20 persons were assembled there and he instigated all his said persons to misbehave with me by false representation and he threatened me with dire consequences.

I would like to further inform you that on searching of the said registration number of the motorcycle, I found that said motorcycle is registered in the name of Nibaran Malakar and on searching in the facebook profile of said Sutirtha Raha I found that said rider is not Sutirtha Raha and thus he falsely introduced himself

by taking the name of a reputed person / lawyer but I can identified the said rider and his associates by face to face.


Under the above circumstances I would like to request you to investigate the matter and do needful for the ends of justice.


