With due regards, I, **SMT. SANGJUKTA GHOSH (BISWAS)**,
wife of Sri Amlan Biswas, Daughter of Sri Suddhabrata Ghosh,
Presently residing at Prantik Apartment, 1, Uday Shankar Sarani,
Deshbandhupara, P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling, Pin-
734004, would like to lodge this written complaint before your good
office to the effect that **SRI AMLAN BISWAS**, Son of Sri Amitava
Biswas, resident of Santoshi Apartment, 40, Milan Park, Gorla, P.O.
Goria, P.S. Patuli, Kolkata - 700084, is my legally married husband
and our marriage was solemnized on 27.04.2021, as per the provision
of the Special Marriage Act, 1954, before the Marriage Officer Sri Bijay
Kumar Ghosh of Siliguri, Dist. Darjeeling and social marriage ceremony
was also performed on the very same day at Subrata Sangha Club
premises, Deshbandhu Para, Siliguri, in presence of our respective
family members, friends and well wishers.

After our marriage, my husband brought me at my matrimonial
house as mentioned aforesaid, where we have started to live and
cohabited together as husband and wife along with my in laws
members.

Just after two days of our marriage, my parents-in-law in
conspiracy with my elder married sister-in-law started to cause mental
torture upon me. At the time of our marriage, my husband used to work
in a private sector of Mindtech Software and presently, he has been
working as an employee of HCL Company and his yearly package of
Rs. 24 Lakhs. After my marriage, I also joined in a private company on
17.05.2021 and used to get salary of Rs. 14,000/- only per month and
since in the month of July, 2021, my father-in-law asked me either to
pay a sum of Rs. 5,000/- only per month for the purpose of household
expenses or to resign from the said job and I being the newly married
wife, had compelled to obey the decision of my father-in-law and
started to pay a sum of Rs. 5,000/- only per month to my father-in-

In spite of giving such amount to my father-in-law month by
month, they were not at all satisfied and always show their
dissatisfaction towards me as their daughter-in-law and also
misbehaved with me on every petty issues though, I tried my level best
to act as per their directions considering my future conjugal life with a
hope that in near future, they will change their behaviour upon me and
rectify themselves but, all my hopes have gone in vain and day by day
they have increased the intensity of torture upon me without any just

cause and reason and started to place different types of demand of dowry and created pressure upon me to bring the same either from my parents or from my own income and as and when, I refused to accept their said illegal demands, they did not bother to cause tremendous mental torture upon me and also abused me with filthy and offensive languages and if I made any protest against their said illegal acts and activities, they did not hesitate to assault me physically.

Sir, in order to fulfill their illegal demands, they have shifted the entire burden of my matrimonial house upon me and forced me to do all the household chores in my matrimonial house single handedly and I had compelled to do all the household chores in my matrimonial house as per their demands for the sake of my future conjugal life but in spite of that, they were not satisfied with me.

It is very painful to mention here that my in laws members in conspiracy with my husband always taunting me with regard to my looks and my husband also stated that he has no love and affection towards me as his legally married wife as he was not at all ready and willing to marry me at any point of time and if he gets a chance, he will marry again with another woman after dissolving our marriage tie and on contrary, he threatened to oust me from their house permanently. They did not provide sufficient food to me for which, most of the day, I used to pass my days without having any food and also asked me to bring money from my parents for every expenses towards me like foods, clothing, medicines etc. It is very painful to mention here that at the time of marriage, my parents had given one suit piece to my husband including the other articles as per their demand and in one occasion, when I requested my husband to make the said suit, my husband and my parents-in-law jointly in conspiracy with each other asked me to bring the amount for the manufacturing cost of the said suit from my parents as it is their duty to pay the said amount and in this way, they always humiliated me. They had also abused my parents by throwing some filthy and abusive languages and I had no right to protest against their said illegal behaviour and if any point of time, I raised my voice, they will not bother to assault me physically and such type of incident occurred on several occasions. They also not allowed me to talk over headphone with my family members and they had clearly stated that if I want to talk with my family members, I have to talk with them after switch on the speaker of the phone in their presence. Thereafter, my parents-in-law namely Sri Amitava Biswas and Smt. Silpi Biswas and my elder married sister-in-law namely Smt. Satabdi Biswas in conspiracy with my husband had started to create pressure upon me to bring a golden bracelet weighing more than 50 grams from my father and when I told them that my father has already incurred a huge expenditure for the purpose of my marriage ceremony and it would be very difficult for my father to give a bracelet at this moment and hearing the same, they became furious and abused me and my father with filthy and slang languages and due to their aforesaid torture, my mental condition were deteriorating day by day.

In the first week of June, 2022, I found and noticed that my husband is behaving abnormally and he was constantly smoking during the entire night without having any sleep and when I asked him whether he is facing any trouble or not, he became furious and started to abuse me and finding no other alternative, I narrated the same to my mother-in-law and hearing the same, my mother-in-law told me as to why I did not inform her earlier as her son has been suffering with severe disease of psychological problem since long time but the said facts has intentionally suppressed by my husband and in laws members prior negotiation of our marriage. During that period, I also noticed that my husband moving in the room in a naked condition and also started to urine and latrine on the bed and his behaviour was unnatural. Thereafter, my parents-in-law brought him before his regular physician Dr. Sourav Das and treated him and thereafter as per advice of the Doctor of Aashirbad Trust, Registered under Mental Health Act, 1987, he was admitted there for his recovery of psychological problem. After the said incidence, my parents-in-law and married sister-in-law had started to blame upon me by saying that I am responsible for the said psychological disease of my husband though, it is very much within their knowledge that prior our marriage, my husband had been suffering with the said disease and over this issue, they constantly started physical and mental torture upon me with an intention to oust me from my matrimonial house and finding no other alternative, on 25.07.2022, I have compelled to left my matrimonial house, leaving my said private job permanently and started to reside at my parental house under compulsion and during my stay at my parental house, my husband and other in laws members have constantly created pressure upon me to give my consent on the mutual divorce application as my in laws members want to arrange the marriage of my husband with another woman and since the date of my refusal on their said proposal, all my in laws members have started to threaten me and my family members with dire consequences and due to their such type of threatening, I have been passing my days with extreme fear and mental anxiety.

I, therefore, request you to kindly investigate into the matter properly and please take appropriate strong legal action against my husband and my in-laws members as mentioned above as per the provision of law and obliged thereby..
