water and Soda. since 2007. Factory get closed  
due to lock down in March 2020. We respect  
added one of the care taker who was working  
their from past 17 years Name → "Rudra Narayan"  
Recently, we planned to visit the factory on  
6th of April 2023. So that we called our technical  
head to inform Guard on 6th of April, 2023.  
He went to visit and handover the keys and  
Once we reached there we found the Guard  
Number, and person was missing. We tried call  
the Guards several times but the phone got switched  
off. I came to Siliguri on 7/4/23 but the Guards  
were missing. We managed to get inside the  
premises, we found the list of machinery that  
was stolen :-
