I, Sri Ritesh Kr. Gupta, son of Mahesh Prasad Gupta, resident of 6, APC Sarani, Desh Bandhu Para, Ward No. 29 of SMC, P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling, Pin 734004, beg to respectfully state that yesterday date about 11/04/2023, at 10.30 -11.00 A. M. my elder brother Sri Rajesh Gupta, (aged about 44 years), and his son Ashmit Gupta, (aged about 18 years) jointly enter forcefully inside my house and room firstly uses offensive and abusive language upon me and my wife Madhu Gupta, (aged about 30 years). During that time Rajesh Gupta and Ashmit Gupta both are attacked to me then Rajesh Gupta and Ashmit Gupta beaten and kick by hands and leg fist & blows upon me. My wife came for save my life then Rajesh Gupta outrage her modesty. Then they both are very furious and broken my room along with some articles like stand fan, house door and bed. Due to their sudden attack and beaten upon me I was fell ill and my wife admitted me in Siliguri District Hospital where I was admitted and treated.

The above persons Rajesh Gupta and Ashmit Gupta both are very dangerous and furious in our locality.

Under the above please take appropriate action against two accused and punished as per Indian Penal Code and oblige.
