With due respect, I, SMT. REENA GUPTA, @ RINA CHOWDHURY W/o Ajay Prasad D/o Sri Shivjee Chowdhury Champasari, Opp. Union Bank of India, Vidya Nagar, P.O – Champasari, P.S- Pradhan Nagar, District – Darjeeling, 734003 would like to inform you that on 18 – 2 – 2003 my marriage was solemnized with one SRI AJAY PRASAD, S/o Late Ramawatar Prasad C/o Ramautar Prasad F. L. Shop, Rangpoo Bazar, Rangpoo Upper Bazar, MW 31 A, NH Way, Near Rangpoo Forest Block, P.O & P.S – Rangpoo, District – East Sikkim. At present residing at C/o Gopal Gupta Dashkarma Bhandar, D.I. Fund Market, Kelahati, Opposite Siliguri Police Station, P.O & P.S – Siliguri, District – Darjeeling at Sahanai Bhawan, Subhash Pally, Dalkhola, P.O & P.S – Dalkhola, District – Uttar Dinajpur according to Hindu rites and customs. At the time of marriage my parents and near relatives have fulfilled all the demands of dowry of my husband and in-laws and after marriage I have started my conjugal life with my husband Ajay Prasad at Gangtok as well as Rangpoo and Champasari, Siliguri, Darjeeling. Out of our wedlock I became the mother of two female children.

Since very beginning of my marriage I was subjected to mental and physical torture from the end of my husband and other near relatives of my husband specially Smt. Sunita Prasad the sister of my husband and her husband Sri Gopal Prasad both are resident of C/o Gopal Gupta Gosusala Road, Babupara, P.O & P.S – Siliguri, District – Darjeeling and both have started inducing my husband to demand money from my parents and as per advice of the said Gopal Prasad and Sunita Prasad my husband has started demanding more dowry and to fulfill their lust of money and to save my matrimonial life my parents have started fulfilling the illegal demands of my husband. And lastly on 9 – 10 – 2017 I was ousted from my matrimonial house and took shelter at my parental house and thereafter my parents have purchased one landed property in my name at Champasari and they have also constructed building on the same for my accommodation and accordingly since 22 – 2 – 2018 I have shifted myself in the said newly constructed house and my husband has started visiting in

my said house off and on. Be it mention here that during our marital life at Champasari, my husband who is a habitual drunker and drug addicted person has again started torturing me by leveling wild allegations against my character and modesty. On 20 - 12 - 2019 all of a sudden without any reason my husband has shifted himself in the house of his sister Sunita Prasad and during his stay in the house of Gopal Prasad, my husband and the said Gopal Prasad and Sunita Prasad have started leveling wild allegations against me about my character. I have bear all the mental and physical torture of my husband and the said Gopal Prasad and Sunita Prasad with a hope that they will rectify themselves but when it became un bearable, I have filed divorce case without initiating any criminal case against them to save their prestige and social image and when the tortures became unbearable on 12 - 9 - 2022 I have file divorce case against my husband having Matrimonial Suit No - 352 / 2022 and the same is pending before the Ld. Fast Track Court at Siliguri and after having the information about the said divorce case, my husband has completely stopped to bear the expenses of me and my minor children and ultimately I have filed an application Under Section 125 Cr.P.C before the Ld. ACJM, Siliguri having M.R Case No - 31/2023 which is pending before the Ld. J.M 4th Court Siliguri for disposal. After having the information about the maintenance case, my husband with intention to lower my prestige has started circulating my photos in social media by making reels and the said Gopal Prasad and his wife Sunita Prasad have started circulating wrong massages against me in society to minimize my prestige for their illegal gain and wrongful loss to me.

Sir inspite of both the above numbered proceedings, neither my husband nor the said Gopal Prasad and Sunita Prasad have rectified themselves and continued their mental torture upon me. On 11 - 4 - 2023 my husband has uploaded reel on his instagram social site having his ID No - ajayprasad2650 and now it became unbearable for me to tolerate the mental torture of my husband and Gopal Prasad and Sunita Prasad as such I am constrained to lodge my FIR to protect myself as well as my minor children.

So requesting you to investigate the matter and take necessary legal action against the above named persons for the interest of justice.
