As we interrogated the girl, we discovered that the girl originally from Assam and heading to Delhi Nodia along with a person name Santosh Kumar sahu for domestic work and lady name Hupni Tudu helped her to get here in siliguri, but she doesn't have proper knowledge of the place and work, in order to make conformation we tried to communicate with her family but we failed due to unavailability of the phone number. Hence, in regard of their safety and protection, we communicate to CWC member siliguri Mr. Sekhar Saha as per the verbal order of CWC member Mr. Sekhar Saha, we are directed to hand over the recovered girls along with the two person at police your station for further process. We are thanking you for your cooperation and support.
