In producing herewith arrested person namely Jakir Hussain (32) S/O Serajul Haque of Mamtapara, PS: New Jalpaiguri, Dist: Jalpaiguri along with one blue color "SPEEGO" E-Rickshaw (Toto) without Registration Number loaded with (1) 01 (one) piece of corrugated GI Sheet length about 20 feet approx, (2) 06(six) pieces of corrugated GI Sheet length about 04 feet approx (3) 04 (four) pieces of corrugated GI Sheet length about 14 feet approx and (4) 07 (seven) pieces of 3x3 inches square iron pipe length about 20 feet approx.

I, SI Buddha Tamang, Officer In-Charge of Canal Road Traffic Outpost do hereby lodge a written complaint against the above named arrested person to the effect that on 10.04.2023 from 12:00 hrs while performing motorcycle mobile duty at Canal Road area found above noted E- Rickshaw (without Registration Number) carrying Iron rods and G.I. Sheets in hazardous condition defying the order of concern authority, which is dangerous to himself and other road users and might invite fatal accident.

Accordingly I detained the above mentioned e-rickshaw and its rider. On being interrogation he identifies himself as (1) Jakir Hussain (32) S/O Serajul Haque of Mamtapara, PS: New Jalpaiguri, Dist: Jalpaiguri but he is unable to produce any valid documents in respect of his e-rickshaw and loaded iron rod and GI Sheet and also failed to give any satisfactory reply for carrying such iron rods and GI Sheets in hazardous condition through busy public road. As such I arrested him u/s 41 Cr.PC and seized E-rickshaw under proper seizure list.

I therefore pray before you to start a specific case against above named arrested person under proper section of law and arrange for its investigation.
