Sub: Written Complaint for lodging an FIR regarding theft of entire Mobile Tower, i.e. Roof Top Tower, along with all of its components/ equipments & fittings from our Telecom Tower Site.

Sir,

I, Sri Kanchan Bagchi, aged about 49 Years, son of Late Chitta Ranjan Bagchi, working as Senior Engineer at GTL Infrastructure Limited, having its Circle Office at 'Shaila Tower', 7th Floor, Plot-J1/16, Block-EP&GP, Saltlake, P.S. Electronic Complex, Kolkata-700091, do hereby lodge this complaint on behalf of the above named company, viz. my employer Company, against unknown person/persons to the effect that we had a non-radiating tower at the rooftop of the building at the land of (1) Sri Uma Shankar Prasad, (2) Sri Uday Shankar Prasad, (3) Sri Sanjay Kumar Prasad, all sons of Late Raghunath Prasad, located at Satyajeeet Nagar, Green Park, Mallaguri, ward No-46 of Siliguri Municipal Corporation in Mouza- Ujanu, Khatian Nos. 169, 170, 171, J.L. No. 86 (108), L.R. Plot No. 72/313, P.O.-Pradhan Nagar within P.S. Pradhan Nagar, District - Darjeeling, since long.

That the said tower and its components / all equipments (as mentioned in the **Annexure - I** as written below) have been unlawfully dismantled and stolen by unknown miscreant/miscreants prior to 14th March, 2023 as reported by our technician/field staff on 14th March, 2023 itself, and the information of said theft is finally confirmed on 31st March, 2023 viz. on this date, by final field verification by me. The value of the materials stolen is to the tune of Rs. 9,66,437/- (WDV Value) after deducting its depreciation reserves.

Humble request to take your cognizance of the said theft as mentioned hereinabove of this complaint and register a case and arrange to investigate it accordingly for the ends of justice.
