Reference: Regarding patient Mr Doman Mahato who reported to hospital in Brought in Dead Condition.

Dear Sir.

This is in reference to the incident of brought dead of patient Mr Doman Mahato 48 year's male, resident New Pokhaijote Mallaguri PO – Champasari PS – Pradhan Nagar, Siliguri.

- We hereby would like to inform the following:
  - 1. Patient Mr Doman Mahato 48 year's old male brought in emergency and was clinically dead on arrival at our premises MEDICA NORTH BENGAL CLINIC at 5:25 pm on 15/04/2023.
  - 2. Patient Mr Doman Mahato was previously admitted at Medica North Bengal Clinic on 3rd April 2023 with alleged history of hit by a bull at Mallaguri at 5:00pm by polytrauma in body, Left ear bleeding, multiple cut injury in body. MLC intimation was sent to Pradhan Nagar Police Station on 3rd April 2023 MLC no: 797. Please find the copy of the MLC enclosed as Annexure- 1
  - 3. Patient was operated on 04th April 2023 for Craniotomy and evaluation of SDH + elevation of depressed skull fracture. During operation patient's fracture was identified and fixed and craniotomy was done.
  - 4. Patient was stable at the time of discharge on 11th April 2023. All necessary medications were prescribed and patient was advised for follow up after 10 days. Please find enclosed the copy of Discharge Summary as Annexure- 2
  - 5. On 15th of April Patient Mr Doman Mahato was brought in emergency at Medica North Bengal Clinic at around 5:00 pm. On examining the patient blood pressure was not recordable, pulse was not palpable, no body movement was observed, flat line was observed in all leads of ECG and on the basis of the above examination patient Doman Mahato was declared clinically dead on arrival at our emergency at around 5:25 pm.
  - 6. After declaration about the death of Mr Doman Mahato patient guardians and relatives vandalized the hospital property, molested the security guards and other staff of hospital with around 40 to 50 number of people inside the hospital. This has created lot of damage to our property and would like to request you to kindly take strict action against the culprit.
  - 7. Intimation of mob violence was given to Pradhan Nagar Police Station at around 5:36 pm.

In view of the above we are hereby submitting the first information report and request you to kindly take the handover of the deceased and perform the post mortem at the earliest.
