
Respected Sir,

With due respect and humble submission I, Iftakar Alam
son of Panvir Ali of Near Blue Mountain Club & Resort
P.O. Sarbati and P.S. Pradhari Nagar Siliguri District-Darjeeling
would like to inform you that today around 4.30 pm
when I was working in the exterior of Queens Residency
then from above I could see that said Toppay Bhutia
called our owner of building Shibu Chetri @ Shiva Chetri
and was talking in healthy manner and after the talk
when Shiva Chetri was returning and opening the gate
of Queens Residency he slapped him and started hitting
him with one iron rod in his legs and chest and
trying to strangle him. When other labourers watched
that they went to rescue Shiva Chetri and at that
time said Toppay Bhutia snatched one gold chain from
Shiva Dada's neck and started running towards his
place where he got hit by the iron gate as he was
in hurry and suffered some injuries and started bleed-
ing and he in turn threatened everyone that he
have contacts with many influential people and
will stop this construction and file a case against

Shira Chatterji. As Sir said Toppay Bhutia is also a promoter and since many days he was disturbing us and stopping our work due to jealously sometimes his labour used to steal some iron-bods, some cement-bags just to frustrate us and today this thing happened. When said Toppay Bhutia and his labours hit Shira Chatterji we all went to his help and admitted he is in North Bengal Medical College where he is serious and all the incident is recorded in CCTV footage. After a while a police van come and arrested our labours who were not the part of the fight but just helping Shira Chatterji with his injuries. Therefore Sir kindly take strict action against said Toppay Bhutia and arrest him and do justice.
