

I beg to bring to your attention the ~~the~~ Shiva Chettri, son of
Nar Bahadur Chettri, R/o. MIG, Uttarayan Housing, Matigera was
developing a building adjacent to our construction site. On
numerous occasions Shiva Chettri has been harassing us by dropping bricks
on our site, making his labourers urinate over our side, etc.

Finally today, my husband Shri Topgyal Tshering Bhutia ~~with~~
confronted Shiva Chettri at about 3:30 PM, and Shiva Chettri picked
up a fight with my husband and called him derogatory terms
like "phadey adivasee" and "unpakh junglee" and threatened to have
him killed.

Afterwards, around 4 pm, Shiva Chettri and Rasul Alam and about
25-30 unknown persons entered into our site and using
iron rods, hammers, wooden battam and other sharp objects
attacked my husband with the intent to kill him. He is battling
for his life at Niradita Nursing Home due to serious injuries to
his head, chest and body. Our construction site was also destroyed.
I belong to the scheduled tribe and being helpless housewife I have
come before you requesting you to register an FIR and take
immediate action against these accused persons.
