Sir,

In producing herewith two accused persons namely Ganga Ram s/o Mahindar Mukhia of Pipuda, PS Kushesarastan, Dist. Darbangha, Bihar and Bikash Mukhia (27) s/o Ram Chandra Mukhia of Pipuda, PS Kushesarastan, Dist. Darbangha, Bihar under arrest along with following articles under proper seizure.

1. 85 (Eighty Five) sachets of Officer's Choice Grand Whiskey (each sachet containing 180 ml, Total 15.300 liters)
2. 5 (Five) Bottles of Mc. Dowell's Celebration Rum (each bottle containing 750 ml, Total 3.750 liters)

I, SI Abhishek Theengh of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person namely Ganga Ram s/o Mahindar Mukhia of Pipuda, PS Kushesarastan, Dist. Darbangha, Bihar and Bikash Mukhia (27) s/o Ram Chandra Mukhia of Pipuda, PS Kushesarastan, Dist. Darbangha, Bihar to the effect that today on 18.04.2023 at 20.15 hrs. received a source information that two persons has been standing with huge quantity of illicit liquor without any valid license at Siliguri Junction Bus stand under Pradhan Nagar PS.

Accordingly, I informed the matter to your good notice and as per your kind direction I along with C/762 Mojobul Rahaman and CV/242 Rakesh Mangar had been to Siliguri Junction under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found two persons was standing at Siliguri Junction Bus Stand with one bag under their joint possessional. Subsequently, I along with my force cordoned the area and was able to detain the above noted persons. Subsequently on being asked the apprehended persons disclosed their name and identity as mentioned above.

Further being searched the above noted seized articles were found from their joint possession. On demand they failed to produce any valid license/papers for the articles which was recovered from their joint possession. On further interrogation they stated that they have been involved in selling and possessing of liquor without any valid license for last 06 (six) months for their illegal gain. Then I seized and labeled the above mentioned illegal illicit liquors under proper seizure list in presence of witness and arrested the above-mentioned person namely Ganga Ram s/o Mahindar Mukhia of Pipuda, PS Kushesarastan, Dist. Darbangha, Bihar and Bikash Mukhia (27) s/o Ram Chandra Mukhia of Pipuda, PS Kushesarastan, Dist. Darbangha, Bihar after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 20.45 hrs to 21.55 hrs at the spot and arrested her after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Ganga Ram s/o Mahindar Mukhia of Pipuda, PS Kushesarastan, Dist. Darbangha, Bihar and Bikash Mukhia (27) s/o Ram Chandra Mukhia of Pipuda, PS Kushesarastan, Dist. Darbangha, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
